#### Information war

- EU / UK Ban on RT & 4 other channels
- -Actions by private actors Meta/ TikTok/ YouTube geo-blocking RT/ Sputnik in EU
- War propaganda e.g. Z symbols
- Actions to undermine enemy morale/ boost allied morale



## Legal proceedings



- International courts/ tribunals
- ICJ
- ECtHR up to 16<sup>th</sup> Sept, 2022
- · ICC
- Independent Intl Cmn of Inquiry on UA UNHRC
- Hypothetical tribunal on aggression (GA/ multilateral)
- Hypothetical tribunal on compensation
- National courts
- Ukrainian
- Other universal jurisdiction/ enforceability requires legislation

#### Sanctions



- -- UNSC e.g. Iraq/ DPRK
- -- UNGA UfP (1950) e.g. colonial Portugal/ SA
- -- EU 7<sup>th</sup> package 21<sup>st</sup> July limited use of jurisdiction/ individual-based/ national laws RU & BY
- asset freezes RCB / NordStream 2/ trade/ investment/ finance (e.g. SWIFT)/ ports and airports
- -- Immigration measures against nationals
- Asset confiscation / measures against professional enablers

### Diplomatic isolation



- Expulsion from organisations CoEsuspension/ UN Human Rights Council
- -Expulsion from private organisations -Eurovision/ World Cup etc
- Expulsion of "diplomats"/ spies
- Expulsion of other diplomatic staff
- Interruption of diplomatic relations(Portugal/ SA)

#### Assistance with combat functions



- Intelligence e.g. Moskva
- Matériel
- Finance e.g. EU Peace Facility Council Decision (CFSP) 2022/338 & 239/2022/1284 & 1285 €2.5 Bn in total including for equipment and platforms designed to deliver lethal force Ireland excluded under art 4(4) of 2022/338

## Legal to-do list

- -- Intensify information war
- -- Legal proceedings including ECtHR vs RU
- Domestic legislation re civil & criminal liability
- Enhance sanctions/ broad jurisdictional basis/ beyond individuals/ confiscation/ RU/BY/ collaborators
- -- Further diplomatic isolation
- Support combat functions
