Privacy Statement for Qualified Lawyers Transfer Test

We are the Law Society of Ireland of Blackhall Place, Dublin 7, Ireland (the “**Law Society**”, “**we**”, “**us**”, “**our**”). We are the educational, representative and regulatory body of the solicitors' profession in Ireland.

We take our responsibilities under applicable data protection law, including the General Data Protection Regulation and implementing legislation such as the Data Protection Act 2018 very seriously. The purpose of this notice is to inform you of the data relating to you that we may collect and use in connection with your application for a Certificate of Eligibility and/or your

application to sit the Qualified Lawyers Transfer Test (“QLTT”), and the uses (including disclosures to third parties) we may make of such data.

Personal Data that we collect and Process

We will collect and process personal data relating to you in connection with your application for a Certificate of Eligibility and/or your application to sit the QLTT. This personal data may include

- your name and contact details, including your address, phone number, email address and post code;
- your date of birth;
- your nationality;
- photographic identification, including copies of your passport or driving licence;
- where necessary, a copy of your marriage certificate or statutory declaration;
- your educational background, including a copy of your degree certificate;
- your credit/debit card or bank account details;
- details of your professional training, practice and experience;
- a certificate of good standing from the professional body in the jurisdiction where you have been admitted;
- your lawyer registration number in the jurisdiction where you have been admitted;
- character references and where necessary, references confirming post qualification experience;
- details of any previous sittings of the QLTT or the Law Society’s Final Examination – Part 1;
- your examination script and result;
- where relevant, evidence and details of any disability you may have, including details of any mental illness;
- where relevant, information relating to a finding of professional misconduct against you by a disciplinary tribunal;
- where relevant, details of your suspension from professional practice by the professional authority in the jurisdiction in which you have been admitted;
- where relevant, information relating to the commission or alleged commission of a criminal offence;

- where relevant, information relating to your bankruptcy;
- any other personal data which you provide to us directly.

Purposes of Processing and Legal Basis

We will use personal data relating to you for the purposes of:

- processing your application for a Certificate of Eligibility and/or to sit the QLTT;
- ensuring you meet the requirements for a Certificate of Eligibility and/or to sit the QLTT;
- administering the QLTT, marking your exam scripts, providing you with your results and administering any appeals;
- contacting you in order to provide you with updates in relation to your application for a Certificate of Eligibility and/or to sit the QLTT;
- where necessary, providing adapted arrangements for applicants with a disability to sit the QLTT;
- *generating and analysing statistics regarding the QLTT;*
- *to comply with our legal and regulatory obligation.*

The legal bases on which we collect, process and transfer your information in the manner described above are:

- that this is necessary for the performance of a contract with you or in order to take steps at your request prior to entering into a contract;
- our legitimate interests in regulating the solicitors' profession in Ireland and ensuring the proper management and functioning of the Law Society. We will not process your

personal data for these purposes if to do so would constitute an unwarranted interference with your own interests, rights and freedoms; and

- that this is necessary for compliance with a legal or regulatory obligation that applies to us; and
- to perform a task carried out in the public interest.

The legal bases on which we collect, process and transfer special categories of data relating to you in the manner described above are:

- that this is necessary for reasons of substantial public interest; and
- that you have given your explicit consent to such processing.

Recipients of Data

We may disclose your personal data to other organisations in connection with the above purposes, including:

- to third parties who we engage to provide services or benefits to us or to you, such as professional advisers, auditors, and examiners; and
- to competent regulatory authorities and other bodies where requested or required by law.

Requirement to Provide Data

You are not under a statutory or contractual duty to provide us with any personal data. However, there are some pieces of information that you must provide to us so that we can process your application to for a Certificate of Eligibility or to sit the QLTT. If you do not provide us with this information, we may not be able to provide you with a Certificate of Eligibility or to process your application to sit the QLTT.

Retention

We will not hold your data for longer than is necessary. We may retain your personal data for the duration of your relationship with the Law Society and for such period of time thereafter as is necessary to comply with our legal and regulatory obligations.

Retention Period for Examination Scripts

As examination scripts are personal data, the Society will not hold examination scripts for longer than necessary. Examination scripts will be securely destroyed once all possible rechecks have been exhausted, within six months of the date of publication of the recheck results for the relevant examination sitting.

Transfers Abroad

In connection with the above we might transfer your personal data outside the European Economic Area, including to a jurisdiction which is not recognised by the European Commission as providing for an equivalent level of protection for personal data as is provided for in the European Union. If and to the extent that we do so, we will ensure that

appropriate measures are in place to comply with our obligations under applicable law governing such transfers. These may include entering into a contract governing the transfer that contains the ‘standard contractual clauses’ approved for this purpose by the European Commission. Your rights

You have the following rights, in certain circumstances and subject to certain restrictions, in relation to your personal data:

- *Right to access the data* – You have the right to request a copy of the personal data that we hold about you, together with other information about our processing of that personal data.
- *Right to rectification* – You have the right to request that any inaccurate data that is held about you is corrected, or if we have incomplete information you may request that we update the information such that it is complete.
- *Right to erasure* – You have the right to request us to delete personal data that we hold about you. This is sometimes referred to as the right to be forgotten.
- *Right to restriction of processing or to object to processing* – You have the right to request that we no longer process your personal data for particular purposes, or to object to our processing of your personal data for particular purposes.
- *Right to data portability* – You have the right to request us to provide you, or a third party, with a copy of your personal data in a structured, commonly used machine readable format.
- *Right to withdraw your consent* – Where our processing of your personal data is based on you having provided your consent, you have the right to withdraw such consent.
