Step 1: Preliminary Examination

If you are the holder of a degree from a college / university outside of Ireland and the UK, you will need to make an application to the Law Society FE-1 Section for exemption from sitting the Preliminary Examination.

Application will need to include:

- 1. Certified copy of your degree certificate
- 2. Certified copy of your passport

The application fee is €45. Bank details for payment will be provided to the applicant on receipt of the application.





Step 2: Final Examination - First Part (FE-1s)

2 sittings per year spring and autumn 8 subjects Tort, Company, Equity, Constitutional, Criminal Law, EU, Property, Contract €115 per subject

You can register to sit individual FE-1 exam subjects on the Law Society website.





Step 3: Secure and register a training contract with a practising solicitor in Ireland.

The solicitor must have at least 4 years Irish practice experience and either be a partner or a sole practitioner or be employed as an in-house solicitor.

(Cost to register a training contract €840)

Step 4: Professional Practice Course (cost €10,500)

September to April full time course

Must have a training contract to register

Fulltime course is eligible for SUSI grant support

Subjects: applied land law, probate and tax, business, employment law, family law, civil and criminal litigation

Skills: civil and criminal advocacy, interviewing and advising, legal research, legal presentation skills, legal writing and drafting, negotiation and professional development)

4 advanced elective learning modules to be completed after PPC [May – July] (**cost €1,656** in total if completed with the Law Society)

Extra curricular activities include competitions, sports and yoga etc.

Course can also be completed on a part-time & distance learning basis also by attending the Professional Practice Course (Hybrid)

Step 5: Complete a 24 month training contract commencing after the end of the Professional Practice Course

Gain experience in 3 distinct areas of law and develop solicitor skills

The Myths

- All trainees have contacts in the legal profession
- You might get a contract if you work for free
- Places are limited to those with 2.1 degrees

The Truth

- 80% of trainees have no contacts at all
- 96% of trainees in paid traineeships
- 539 traineeships were offered to trainees in 2021

TRAINEES & TRAINING FIRMS

60% Women & 40% Men

48% 20 – 25 years old, 39% 26 – 30 years old, 14% 30 and over

Six largest firms 40% of training places 84% places in Dublin
