GARDA REFORM SHOULD FOCUS ON COMMUNITY POLICING AND RESTORATIVE JUSTICE

The Law Society made 14 recommendations to the Commission on the Future of Policing urging reform across a number of areas including:

- Simplify the system of governance, oversight and accountability
- Simplify complaints and discipline investigation processes and enhance transparency
- Resource oversight bodies adequately

The Society believes community policing can be particularly effective in rural communities where a lack of adequate policing is perceived among local communities. A review of the Joint Policing Committees and their resourcing is urged.

SUBMISSION TO THE LAW REFORM COMMISSION'S PROGRAMME OF LAW REFORM

The Law Reform Commission's Programme of Law Reform is the principal basis on which the Commission carries out its statutory mandate to keep the law under review with a view to its reform. For the latest fifth programme, the Society focussed its submission on three areas of law:


- Probate, Administration and Trusts

 the law is in need of reform to provide for variations of wills after a death and for statutory wills.
- Human rights reform of the family law system is required, consistent

- with the Society's policy paper Family Law The Future.
- Reforms in the area of criminal justice relating to discipline mechanisms in prison, the defence of not guilty by reason of insanity, the need for legislation to protect the role of solicitors in Garda station detentions, examination of mandatory sentencing and other reform initiatives.

REVIEW OF THE CHILDCARE ACT



The Society recently contributed to a review of the Child Care Act 1991 to identify what is working well within the legislation and its impact on policy and practice, while identifying any gaps or new areas for development.

The Society provided wide-ranging commentary and recommendations based on the experience of practitioners in this important area of law. Recommendations were provided on areas such as child protection in emergencies and special care, issues surrounding jurisdiction and procedures.

RECOMMENDATIONS IN MAHON REPORT NEED TO BE IMPLEMENTED

The Society has submitted its observations on the Department of Justice and Equality's latest report to the United Nations Committee on the Elimination of Racial Discrimination (UNCERD).

The State must reform its efforts to reduce the amount of time that applicants spend in direct provision and to ensure full implementation of all recommendations in the Mahon Report.

The State is urged to widen the scope of family reunification and to consider the impact of the lack of a formal appeal on an applicant's right to access to justice.

The Society recommends making it an actionable breach of discipline for a member of An Garda Siochána to engage in racial profiling and to allow for such complaints to be investigated by GSOC.
